1. BASIS

The Plaintiff, XXXXXXXXXXXX XXXXXXXXXXXX, moved the Court to enter an Order directing TERESA J. JENNINGS, in her official capacity as State Registrar and Director of the Center for Health Statistics, and the WASHINGTON STATE DEPARTMENT OF HEALTH, a state agency, to:

- 1) Record the name of the Plaintiff's mother on the Certificate of Live Birth as XXXXXXXXXX XXXXXXXXXXXX; and,
- 2) Record the age of the Plaintiff's mother on the Certificate of Live Birth as XX years; and,
- 3) Record the age of the Plaintiff's father on the Certificate of Live Birth as XX years; and,
- 4) Issue a new certified long form copy of corrected record to said Plaintiff within fifteen (15) days of service of the Court Order upon the Defendants.

2. FINDING

1 After reviewing the case record to date, and the basis for the motion, the  
2 court finds that on presentation of sufficient proof showing that the  
3 Certificate of Live Birth for the said Plaintiff, as it appears in the  
4 records of the Washington State Department of Health is, in effect, in error.

5  
6 **3. ORDER**

7 IT IS HEREBY ORDERED that the State Registrar and Director, Center for Health  
8 Statistics for the Washington State Department of Health, correct the  
9 Certificate of Live Birth for the Plaintiff, XXXXXXXXXX, born in the City of  
10 XXXXXXXXXX in the County of Cowlitz and the State of Washington, on the XX<sup>th</sup>  
11 day of May, 1700 to be corrected as follows:

- 12 1) To record the name of the Plaintiff's mother on the Certificate of  
13 Live Birth as XXXXXXXXXX XXXXXXXXXX; and,  
14 2) To record the age of the Plaintiff's mother on the Certificate of  
15 Live Birth as XX years; and,  
16 3) To record the age of the Plaintiff's father on the Certificate of  
17 Live Birth as XX years; and,

19 IT IS HEREBY FURTHER ORDERED that the State Registrar and Director, Center  
20 for Health Statistics for the Washington State Department of Health will  
21 cause to be issued a new certified long form copy of aforementioned corrected  
22 record to said Plaintiff within fifteen (15) days of service of the Court  
23 Order upon the Defendants.
